Reminder: The Illinois DCFS Statewide Emergency Placement Services (formerly known as the DCFS statewide emergency shelter system) was established to provide youth in care with a safe and nurturing environment during their reception period into foster care or during a time of crisis. The array of emergency placements is intended to serve as a temporary placement, and can allow the youth to stabilize and self-regulate, in preparation for long-term placement. Children and youth cannot enter an emergency placement unless the child protection specialist or assigned DCFS or Child Welfare Contributing Agency (CWCA) child welfare specialist has made diligent efforts to identify any possible relative, fictive kin, and licensed foster home.

We wanted to provide this information to you to explain why The Baby Fold might be reaching out to you about potential placement. If you have any questions about the process, feel free to reach out to your caseworker or licensing worker.

### Don't forget about our Referral Incentive Program!

If you refer a family for licensure that successfully becomes licensed, with a child placed in the home, you will be rewarded \$150! Referred families must identify you within the first 3 days of the licensing process.

### Foster Parent Rights and Responsibilities #15

Foster Parents have the right to be informed of the Foster Parent Hotline established under Section 35.6 of the Children and Family Services Act and all of the rights accorded to foster parents concerning reports of misconduct by Department employees, service providers or contractors, confidential handling of those reports, and investigation by the Inspector General appointed under Section 35.5 of the Children and Family Services Act. Foster Parents also have the responsibility to know and understand the importance of maintaining accurate and relevant records regarding the child's history and progress; and the responsibility to be aware of and follow the procedures and regulations of the child welfare agency with which the foster parent is licensed or affiliated.
